NelsonHall's recruitment process outsourcing vendor assessment for AMS is a comprehensive assessment of AMS' recruitment process outsourcing offering and capabilities, designed for:

- Sourcing managers monitoring the capabilities of existing suppliers of benefits administration and identifying vendor suitability for benefits administration RFPs
- Vendor marketing, sales, and business managers looking to benchmark themselves against their peers
- Financial analysts and investors specializing in the support services
 sector
- HR decision makers.

Key Findings & Highlights

AMS is a full end to end RPO services provider with ~3.4k RPO employees globally, offering all of the core RPO services from sourcing to onboarding for permanent hires, campus (graduates), executive hires and contingent placements, across 82 countries, supporting 34 languages.

AMS primarily targets large MNCs with global hiring needs. It also has a sourcing only offering called SourceCloud which targets mid-market sized organizations as well as large MNCs, and an out-of-the-box solution called RPO Accelerate for small and mid-sized organization with limited infrastructure.

Services are delivered from seven global client services centers and a network of 39 global offices. It has a local presence in EMEA, North America, Latin America and Asia Pacific.
