NelsonHall's Next Generation managed service program (MSP) vendor assessment for Capita Resourcing is a comprehensive assessment of Capita Resourcing's MSP offering and capabilities, designed for:

- Sourcing managers investigating sourcing developments within MSP
- HR decision makers exploring the benefits and inhibitors of MSP as evidenced by the clients and vendor capability
- Vendor marketing, sales and business managers developing strategies to identify developments and target opportunities within MSPs
- Financial analysts and investors specializing in or covering the HR outsourcing industry and suppliers.

Key Findings & Highlights

Capita Resourcing is part of Capita Plc's People Solutions division, which itself is one of six divisions (restructured for 2018) which form Capita plc.

Capita Resourcing manages 14 MSP programs (with some MSP programs covering up to 17 organizations), with established MSPs in nuclear energy, government, and transport.

Capita Resourcing offers MSP, RPO, and multi-process HR solutions.

Capita plc's People Solutions division total revenue for 2018 was \$672.7m (£498.3m).

Capita Resourcing will focus on driving a total talent engagement people strategy, consulting/advising clients (in areas such as IR35), and digital transformation (as part of the wider Capita Group).
