Who Is This Vendor Assessment For?

NelsonHall's Software Testing Vendor Assessment for Infosys is a comprehensive assessment of Infosys' software testing offerings and capabilities designed for:

- Sourcing managers monitoring the capabilities of existing suppliers of IT services and identifying vendor suitability for software testing services
- Vendor marketing, sales and business managers looking to benchmark themselves against their peers
- Financial analysts and investors specializing in the software testing sector.

Key Findings & Highlights

Infosys provides testing services mostly through four units, of which Independent Validation Solutions (IVS), the software testing practice servicing enterprise clients, is the largest unit.

In FY 2013 IVS had revenues of ~\$621m.

In 2012, Infosys IVS had two interesting developments. It launched an IT infrastructure consulting service in conjunction with Infosys' IT Infrastructure Management Services unit. The offering has positioned Infosys as one of the early vendors with such an offering.

Also the company was awarded a 3-year \$100m contract with a U.S. bank. Services provided by Infosys include traditional software testing services, test environment provisioning and management, as well as IT infrastructure testing. NelsonHall estimates that the contract is one of Infosys' largest standalone testing contracts.

IVS is developing its services portfolio and IPs in priority, focusing on specialized testing offerings. Highest priority offerings include:

- QA consulting (5% of IVS revenues
- Specialty validation (25% of IVS revenues):
 - Performance engineering and testing
 - Packaged application testing
 - Cloud testing
 - Mobility testing
 - IT infrastructure testing consulting
 - Model-based testing
 - Data warehouse testing
 - Test data management
 - Hosting and provisioning of test environments
 - Security testing.



Scope of the Report

The report provides a comprehensive and objective analysis of Infosys' software testing offerings, capabilities, and market and financial strength, including:

- Analysis of the company's offerings and key service components
- Revenue estimates
- Identification of the company's strategy, emphasis and new developments
