Headquartered in London, U.K., Mercans is a technology-enabled managed payroll and HR outsourcing provider, including employer of record services. The company was founded in 2003 to address gaps in multi-country payroll and HRM services across Europe, including recruitment services supporting the oil & gas industry. In 2004, the company opened its office in Dubai to provide services throughout the Middle East and expanded its operations to LATAM in 2008-09.

In 2011, Mercans began providing HRM integration services, focusing on SAP SuccessFactors, UKG, Ceridian, Oracle, Workday, and Microsoft system integration, support, enhancements, and platform upgrades.

Since its inception, Mercans has developed proprietary tools to enable its managed payroll and HR services, dedicating ~80% of its annual revenues toward R&D efforts to enhance its proprietary HR Blizz™ platform.

Mercans' Global HR solutions are organized into the following service lines:

- Employer of Record
- Global Payroll
- Business Process Outsourcing
- Software
- Global Mobility & Talent Management
- Advisory & Compliance.

Across all these lines of business, Mercans supports ~8,000 clients in ~160 countries. The company focuses on the minimal use of subcontractors and third-party providers in delivering its native employer of record services. Mercans currently provides employer of record services for ~1,320 clients and ~16,000 active workers.
